It improves communication and coordinates activities by serving as a single information platform and focal point. Here's how it works:

- 1) Identify:** The system automatically identifies the specific tests, audits and inspections required for each product order.
- 2) Generate and Distribute:** Inspection, lab test and factory audit booking requests are customized, based on your company's predefined parameters, then generated and distributed to the appropriate inspection companies and laboratories. Standardizing and automating the process lowers administrative costs and eliminates duplication of effort.
- 3) Monitor:** The system monitors and validates the inspection and testing process from start to finish. Testing failures are quickly identified, then proactively reported and managed to keep the process on schedule.
- 4) Report:** Inspection and testing results are automatically captured and reported in both summary and detailed form. Having an objective record of vendor performance identifies problem areas and increases accountability.
